Your firm is not bound by its initial decision, and if you decide to reverse your stated intention at a later date, you are requested to advise us by separate letter.
7. The reference of this IFB is IFB-CO-14974-BMD, and all correspondence concerning this IFB should reference this number.
8. This IFB remains the property of the NATO Communication and Information Agency (NCI Agency) and shall be protected in accordance with applicable national security regulations.


