
## TENDER ANNOUNCEMENT

State of Georgia represented by the LEPL State Agency of Oil and Gas of the Ministry of Economy and Sustainable Development of Georgia, acting in accordance with the Georgian Law on Oil and Gas and National Regulation Rules for Oil and Gas Operations in Georgia, is announcing an Open International Tender on free license Blocks VIIB, X and XIWN-M to obtain the blanket license for the use of oil and gas resources. The Tender starts on 1st August, 2024.

## ADDITIONAL INFORMATION

The parties wishing to participate in the Tender shall apply in writing to the Head of the State Agency of Oil and Gas. The State Agency of Oil and Gas will provide with DropBox link from where interested persons/companies can download Information Packages and/or CD with tender Information Packages to all interested parties without any charge but only at the office of the State Agency. Applicants shall have at least 5 year experience of oil and gas exploration.

In case of request, the State Agency of Oil and Gas will send tender Information Packages by express post only when such delivery expenses are prepaid by the requesting party.

The information packages contain the following:

- a) General location and coordinates of the blocks;
- b) The sample of Production Sharing Contract for each License Block;
- c) The minimum obligatory financial and technical terms for each License Block;
- d) The licensing and contracting schedule;
- e) The instructions for submitting bids, including the amount of the participation fee and payment instructions.
